President's Minute

This coming November we'll be asked to render a vote on Initiative 594. This has been promoted as a "common sense" require for background checks every time a firearm is sold. This initiative has also been promoted as the remedy for the "gun-show loophole."

Most of the people I know never read the texts of the initiatives; they rely on recommendations or the ballot descriptions. In the strongest possible terms: **DON'T DO THAT!**

I594 will have a dramatic impact on all firearms owners and anyone who may want to own a firearm. This initiative covers much more than background checks for gun buyers. I've been publishing a step-by-step narrative to understanding I594. I've tried really hard to stay neutral as I present my honest beliefs regarding the different sections of this initiative. As this newsletter goes to press Part 5 is ready for publication. Please take time to read and understand how this initiative will affect you on a day-to-day basis.
