

# RANGE RULES:

- 1. ALL FIREARMS WILL BE POINTED IN A SAFE DIRECTION**
  - AT THE FIRING LINE: DOWNRANGE
  - AT THE CASE/UN-CASE AREA: CINDER BLOCK WALL (UNLOADED)
  - ELSEWHERE IN THE FACILITY: UPWARD (UNLOADED)
- 2. KEEP FINGERS OFF THE TRIGGER UNLESS SHOOTING AT A TARGET**
- 3. FIREARMS WILL ONLY BE LOADED/UNLOADED AT THE FIRING LINE**
- 4. BEFORE LEAVING THE FIRING LINE ENSURE THE FOLLOWING:**
  - ACTION IS OPEN AND CHAMBER IS EMPTY
  - EMPTY CHAMBER INDICATOR IS INSERTED
  - ALL MAGAZINES AND AMMUNITION HAVE BEEN REMOVED
- 5. NO ONE MAY GO FORWARD OF THE FIRING LINE DURING LIVE FIRE**
  - DURING A CEASE FIRE - ONLY RANGE STAFF IS ALLOWED FORWARD OF THE FIRING LINE
- 6. ALL COMMANDS BY RANGEMASTERS AND STAFF MUST BE OBEYED IMMEDIATELY**
  - RANGEMASTERS MAY INSPECT ANY FIREARM FOR ANY REASON
- 7. ANYONE MAY CALL A CEASE FIRE IF AN UNSAFE CONDITION IS OBSERVED**
  - STOP SHOOTING, REMOVE FINGER FROM TRIGGER GUARD, LOWER GUN AND WAIT FOR FURTHER INSTRUCTIONS
  - DO NOT BEGIN HANDLING GUNS DURING A CEASE FIRE
- 8. REPORT ALL UNSAFE CONDITIONS TO A RANGEMASTER**
- 9. REPORT ALL UNINENDED/MISDIRECTED SHOTS TO A RANGEMASTER**
- 10. DISPOSE OF LOOSE AMMUNITION IN THE 'UXO' CAN**
- 11. COMPLY WITH LEAD SAFETY RULES:**
  - NO FOOD ON THE FIRING LINE - WATER IS ALLOWED AT RANGEMASTER DISCRETION
  - AVOID TOUCHING FACE/EYES WHILE SHOOTING
  - WASH HANDS AFTER SHOOTING
- 12. WEAR APPROPRIATE PROTECTIVE EQUIPMENT:**
  - EYE PROTECTION IS REQUIRED AT ALL TIMES ON THE RANGE
  - EAR PROTECTION IS REQUIRED ON THE RANGE WHEN FIREARMS ARE BEING DISCHARGED
- 13. THE FOLLOWING ACTIVITIES ARE PROHIBITED:**
  - SHOOTING .22 AT TARGETS CLOSER THAN 50 FEET (AIRGUN MAY BE SHOT AT 10m)
  - CROSS-FIRING BETWEEN LANES
  - QUICK DRAW SHOOTING FROM A HOLSTER
  - UNCONTROLLED RAPID FIRE (OVER 1 ROUND PER SECOND)
  - USE OF ZOMBIE/HUMANOID TARGETS
- 14. USE ONLY APPROVED AMMUNITION TYPES:**
  - .22 STANDARD VELOCITY (<1200 FPS) IS ALLOWED
  - AIRGUN PELLETS (LEAD PELLETS ONLY – NO BBs OR AIRSOFT) ARE ALLOWED
  - NO CENTERFIRE OR HIGH VELOCITY AMMUNITION
- 15. ANYONE UNDER THE AGE OF 18 MUST FOLLOW THE WSSC JUNIOR SHOOTING POLICY**
- 16. ANYONE UNDER THE INFLUENCE OF DRUGS OR ALCOHOL IS PROHIBITED FROM ENTERING THE RANGE**
- 17. ALL RANGE USERS MUST SIGN IN UPON ENTRY AND OUT PRIOR TO DEPARTURE**

The WSSC may refuse entrance to this facility to anyone at any time. The rangemaster is the authorized agent of WSSC. Anyone refusing to obey the commands of the rangemaster will be asked to leave and reported to the Seattle Police Department.
